- 4 Merchandise whose importation is prohibited shall not be exhibited. The applicant must check in advance in this respect concerning the merchandise. In addition, no explosives or merchandise or decorative material considered to be hazardous shall be accepted for exhibition. Moreover, any merchandise judged by the organizer to be inappropriate for exhibition shall be refused for display. In order to avoid any possible trouble, it is requested that a full and accurate description of the merchandise be given in the section provided in this application form.
- 5 The applicant, as a matter of course, is required to honor, in addition to the rules and regulations of the Show, the laws and regulations of Japan and those of the Tokyo metropolitan government.
- 6 The applicant, after completing the application procedure cannot, in principle, cancel the application. If participation is cancelled less than 120 days before the opening of the show, no refund of the fees already paid shall be done. Also, if payment for the balance of the fee or of the fees due for optional facilities, etc. has not been effected on or before the stipulated date, the organizer reserves the right to revoke the allotted exhibit space and/or exhibit contract at its sole discretion without prior notice and there shall be any refund of the fees already received by the organizer.
